



## **MEMORANDUM OF UNDERSTANDING**

**BETWEEN**

**GAVAR STATE UNIVERSITY (GSU)**

**(THE REPUBLIC OF ARMENIA)**

**AND**

**"ANGEL KANCHEV" UNIVERSITY OF RUSE**

**(THE REPUBLIC OF BULGARIA)**

### **Article I**

The purpose of the present Memorandum of Understanding is the establishment of bilateral cooperation in the field of education and science between Gavar State University (GSU, the Republic of Armenia) and "Angel Kanchev" University of Ruse (Bulgaria), hereafter referred to as Parties.

### **Article II**

For the realization of the purpose of the present agreement the Parties have agreed:

- To realize exchange of academics, researchers, students and administrative staff;
- To promote an establishment of the scientific cooperation in the field of common interest;
- To carry out joint educational and scientific projects and programs;
- To provide mutual assistance in the development of scientific qualification of scientists and lecturers;
- To exchange experience in the development of the advanced methods of education;
- To promote the organization of scientific conferences and joint publications;
- To inform about the results of cooperation and scientific-educational activities of Parties.

### Article III

Parties agreed that the optimal way of cooperation is the establishment of contacts on concrete interests and/or concrete employees and in forms, recognized by the most comprehensible to Parties.

### Article IV

Parties agreed that the cooperation between them will be carried out on the basis of action programs, which will be signed by the representatives of the Parties after the negotiation with participants on conditions, activities and topics/themes. The given action programs will be attached to the present Agreement in the form of its Annex, which will represent an integral part of the Agreement.

### Article V

The Parties understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.

### Article VI

The Parties have a right to make additions in the given Memorandum of Understanding by mutual consent, issued in the form of corresponding reports or agreement.

### Article VII

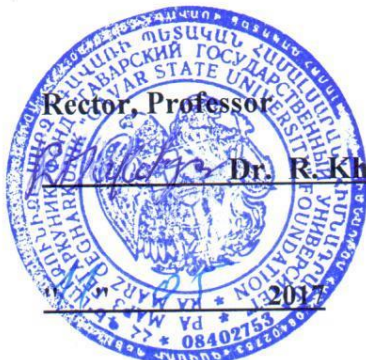
The present Memorandum of Understanding enters into force from the date of its signing and lasts for 5 years and thereafter will be automatically renewed each year, if any of the Parties will not notify in a writing form not later than three (3) months prior till the end of the calendar year about the intention to interrupt the present Memorandum of Understanding under the conditions that all the existing obligations stipulated by the treaty provisions, will be executed.

The present Memorandum of Understanding is made in two originals in the English language.
